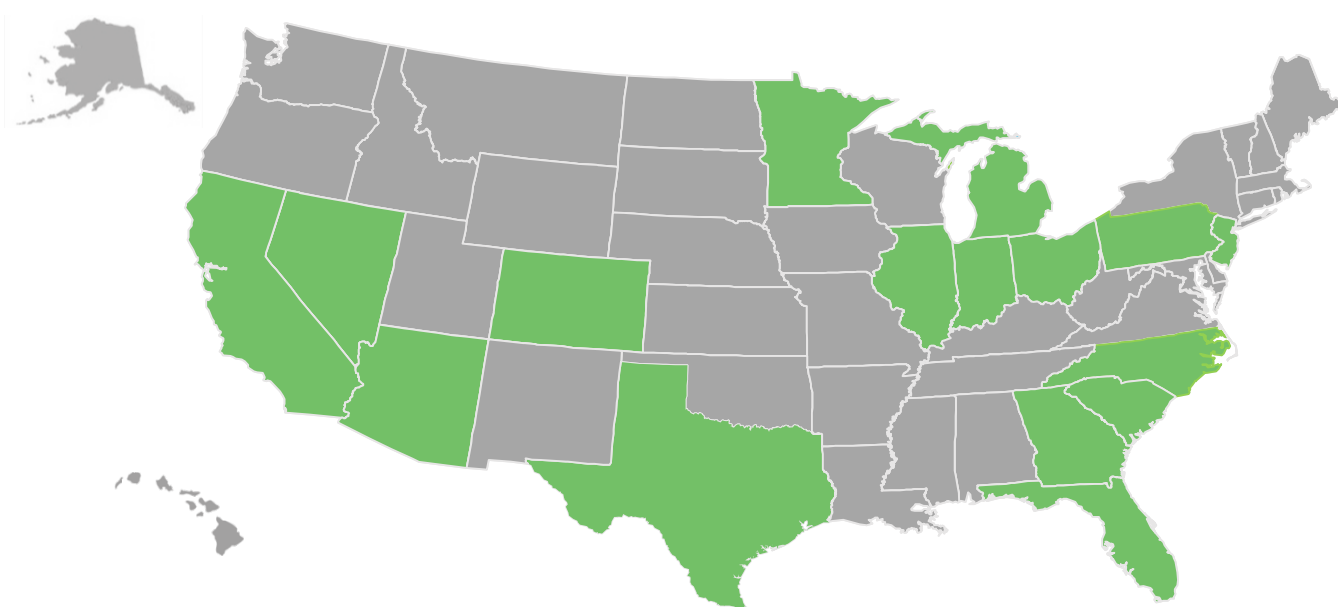

## SELECTED CONSTRUCTION LITIGATION RESULTS

- Defended developers in multiple class and mass actions alleging defective plumbing systems in tens of thousands of homes in Arizona, California, Nevada and Texas, obtaining recoveries totaling more than \$75 million from manufacturers of plumbing components and various insurance carriers.
- In a putative statewide class action in the Middle District of Florida, obtained published decision dismissing tort claims, dismissal of \$2 billion punitive damages claim, *Daubert* rulings striking liability and damages experts, and denial of class certification.
- Obtained rescission of \$17.4 million real estate development project agreement based on developer's fraud concealing non-payment of earnest-money deposit.
- Represented national vehicle-rental company in successfully resolving lien claim in connection with expansion of a rental location.
- Negotiated favorable settlement for manufacturer on claims of construction defects at its test facility.
- Represent municipality in multi-pronged litigation regarding design and maintenance claims of sewer system.
