Representative Matters

Embedded Appellate Counsel for Trial

- Secured summary judgment for a major automotive manufacturer in a wrongful death lawsuit involving product liability claims
- Represented multiple automakers at trial as appellate counsel, leading motions in limine arguments, jury-instruction conferences, and record preservation
- Twice secured judgment as a matter of law as to punitive damages in product-liability cases before trial team ultimately obtained a complete defense verdict

- Procured favorable settlement after pretrial motions practice in multiple-fatality case involving emerging technology
- Obtained trifurcated trial in a consumer-warranty action that paved the way for successful judgment as a matter of law motion

- Obtained affirmance on appeal in the Tenth Circuit after leading successful summary judgment for automotive manufacturer in case involving advanced driver-assistance technologies
- Defended jury verdict in Michigan Court of Appeals in personal-injury case
- Won affirmance of a summary judgment dismissal of product-liability claims in the Tenth Circuit based on arguments about inadequate experts
- Avoided settlement enforcement on appeal to the California Court of Appeal in consumer-warranty action
